Ethics & Professional Practices – This is a four (4) hour class covering the National Association of REALTORS® Code of Ethics and the practical application of the Code. The Code of Ethics is one of the things that distinguish a REALTOR® from a real estate licensee and violations of the code are subject to hearings and possible disciplinary action. The class costs \$45 and includes four hours of continuing education credit. It is also the required class for the GRI (Graduate REALTOR® Institute) designation. The class may be taken at PAR or any other association/board. Please be careful to not confuse this class with the CREC Update class

New Member Orientation – This is a six (6) hour class covering the benefits of membership in PAR, the Colorado Association of REALTORS® and the National Association of REALTORS®. There is also a Navica Training Class, and a Fair Housing segment. There is no additional charge for the class. It must be taken at PAR.
